INTRODUCTION:

We would also like to inform that installation and maintenance of Antivirus Software is at no charge to the Registered Intermediaries.

IMPORTANCE OF ANTIVIRUS SOFTWARE:

Antivirus software helps protect the computer system of the Registered Intermediaries from known malicious programs, called viruses, which attach themselves to a program or file and then spread from computer to computer. **It has been observed that many problems are encountered related to virus which is causing a problem in connectivity as some virus spread through the network causing excessive traffic. As a result, the trading system and the broadcast become slow.**

By installing antivirus software and **keeping it up-to-date**, Registered Intermediaries can help keep your computer free from these destructive viruses and avoid spreading them to other computers. Also it detects and prevents script-type threats that exploit JavaScript™ or Visual Basic: Virus Scan finds them and keeps them from executing

ANTI-VIRUS PROTECTION:

ISS uses McAfee Security's virus detection toolkit to automatically check all executable content and file names in email, ISS then performs hit-defined actions on suspicious messages for fast and reliable protection. Actions undertaken include: rejecting, logging, quarantining and annotating the message.

The Virus Check Module provides complete computer and network security from any email containing a virus, including:

- Detection of Macro virus, Trojan horse & worms.
- Automated updates to virus definitions.
- Servers check every 3 hours for virus definition updates, ensuring the most up-to-date protection available.

- Quarantine reports.
- Total Protection from a Single Console.
- Blocking of ports, file & shared doc.

INSTALLATION PROCEDURE:

For installation of McAfee Antivirus Software on all the computer systems at the Registered Intermediaries locations, the Registered Intermediaries need to install the following files from our FTP site. The file names are

- Framepkg.exe (epo agent)
- VSE80iLEN.zip (for Windows XP/2000)
- VSC451Lens.zip (for Windows 95/98)
- VSE710LEN.zip (for Windows NT memory 64-128mb RAM)

Registered Intermediaries can download these files from the FTP Site i.e. <ftp://144.1.150.51/McAfee>. Once the file is downloaded, they have to install on their systems. Rest of the installation part will be managed by the server at the Head Office.

Apart from this there is word document at FTP named ***Installation & Configuration of McAfee Enterprise 8.0i.doc*** which will guide the Registered Intermediaries how to install McAfee antivirus (only for reference).

PREREQUISITE:

- Remove any antivirus which is installed on all systems at your site e.g. (Norton Antivirus, Esoft, Symantec live update, Escan, McAfee Virusscan Desktop Edition).
- Check system requirement.
- You must have connection from ISS like ISDN, VSAT, Leased line, RF-VPN.

After successful installation, please inform us the undersigned Shri Vikram Rathore (vikramr@iseindia.com) and Shri Vilas Chavan (vilasc@iseindia.com) inform us about the completion of the installation. Also indicate your IP address, Trading Member Code and Contact no. and Computer name for our record.

Note: It is mandatory for the Registered Intermediaries to complete the installation of anti-virus software latest by May 13, 2006.
