	Technical Outlook – Nifty 50, Nifty Bank and BSE Sensex
Nifty 50	Technical Outlook for 04-11-2025: Nifty closed at 25,763.35 on 03-11-2025. Nifty continues to trade in a mild upward trend, staying above its key moving averages, which reflects ongoing strength in the broader structure. However, short-term momentum indicators such as RSI and Stochastic are showing signs of cooling, hinting at a brief consolidation or mild pullback after the recent advance. The MACD remains slightly positive, suggesting underlying bullish momentum is still intact. Overall, the market tone remains constructive, though near-term
Nifty Bank	sideways movement or a small dip could precede the next upward leg. Technical Outlook for 04-11-2025: Nifty Bank closed at 58,101.45 on 03-11-2025. Nifty Bank remains in an overall uptrend, holding above key moving averages, but recent momentum has started to ease. Indicators point to a short-term pause or mild pullback as buying strength cools. The broader sentiment stays positive, suggesting any dip could act as a temporary consolidation before the next leg higher.
BSE Sensex	Technical Outlook for 04-11-2025: Sensex closed at 83,978.49 on 03-11-2025. Sensex is maintaining its overall uptrend, though momentum has eased following a strong rally. The index is consolidating after recently testing resistance, with short-term indicators showing mild weakness but no sign of a major reversal. A brief period of sideways movement or minor correction is likely before the next potential upward move resumes.
