Technical Outlook – Nifty 50, Nifty Bank and BSE Sensex

Nifty 50	Technical Outlook for 16-10-2025: Nifty closed at 25,323.55 on 15-10-2025 and remains in a moderately bullish trend, holding above key moving averages. Nifty is consolidating below resistance at 25,350, with MACD and Rate of Change supporting upward momentum. A minor pause is possible as the Stochastic shows a slight bearish crossover. Overall, the trend stays positive. Holding above 25,000-25,100 keeps the path open toward 25,500+, while a break below 24,900 may lead to a further decline.
Nifty Bank	Technical Outlook for 16-10-2025: Nifty Bank closed at 56,799.90 on 15-10-2025 and continues to trade in a strong uptrend, holding above key moving averages including the 14, 21, and 200 EMAs. Nifty Bank is forming higher highs and consolidating near the upper Bollinger Band, suggesting bullish momentum may persist. MACD remains in a bullish crossover with a slightly widening histogram, and the Rate of Change confirms mild upward momentum. While the RSI is approaching overbought territory, momentum remains intact. A small dip is possible, but the broader trend remains strong. As long as Nifty Bank stays above the support zone of 56,000-56,200, the outlook remains bullish with potential to test or break above the 57,000 resistance. A decisive breakout could lead to further gains, while a fall below 55,800 may signal short-term weakness.
BSE Sensex	Technical Outlook for 16-10-2025: BSE Sensex closed near 82,605.43 on 15-10-2025 and is gradually recovering and holding near recent highs but yet to break above key resistance around 83,000. Sensex is forming higher lows, indicating underlying strength. Overall, the bias is bullish to neutral with room for further upside. A clear breakout above 83,000 would confirm stronger rally potential, while a drop below 81,000 may signal weakening short-term momentum.
