	rather than a trend reversal. Oversold signals hint at the potential for a near-term rebound if buying interest
	revives; however, with continuing volatility and directional clarity yet to emerge, a cautious undertone remains
	appropriate in the immediate term.
Nifty Bank	Technical Outlook for 07-11-2025: Nifty Bank closed at 57,554.25 on 06-11-2025. Nifty Bank appears to be in a
	short-term cooling phase within its broader uptrend. Momentum has softened, indicating a phase of consolidation

	maintaining a constructive broader structure - the recent moderation in strength suggests that a cautious

	short-term pause within its prevailing uptrend. After a steady advance, momentum indicators such as MACD and
	RSI reflect moderation, while the index has eased from the upper Bollinger Band. Mild profit-taking suggest
	reduced buying strength, pointing to a phase of consolidation or limited pullback. However, as long as the index
	sustains above key medium-term averages, the broader trend remains constructive, though a cautious undertone
	persists in the near term.
